Cllr Kevin Connor, Chairman of the planning committee explained in detail the thoughts of the planning committee at its meeting on Thursday 11th April 2019. Cllr Mel Ward questioned the size of the bedrooms in the proposed 12 bungalows. After discussion it was resolved to object to this application subject to the following conditions;

- 1. Ercall Magna Parish Council recognises the need for additional specialist housing in the Borough and accepts that there is some capacity within the Roden Hall site for further development, providing that development is proportionate and appropriate. We support the proposal to retain the original Roden Hall Victorian country house and convert this into age-restricted apartments.
- 2. However, Ercall Magna Parish Council objects to the proposal to also build 12 bungalows within the grounds. This density of new buildings is too great for the site in question and would require the destruction of over a third of the trees currently in situ (15 trees and 1 tree group to be removed out of 43 trees and 1 tree group in total). Critically, 9 of the trees proposed for removal are protected by TPOs.
- 3. The majority of TPO-protected trees under threat would be removed in order to make room for bungalows number 16/17 and 18/19 Ercall Magna Parish Council proposes that these buildings are deleted, reducing the number of bungalows to 8 while allowing the majority of protected trees to be retained and retain and enhance a large, tree-filled, garden area to the East of the site.
- 4. Ercall Magna Parish Council also notes that although the apartments and bungalows will be age-restricted, they will be sold (leasehold) on the open market and will not benefit from any additional staff to support residents. We therefore feel that it is disingenuous to describe the development as a Care Village as no care assistance is being proposed.

5. Although the application states that the buildings will be served by mains sewers, the capacity of the sewerage system in Roden is questionable. Officers will wish to assure themselves that sufficient capacity exists without prejudice to new or existing residents before recommending approval.

6. It was also **resolved** to inform the planning officer that we note the absence of a current ecological report as part of the application.

In addition based on the above the Parish Council wish to register a 'Call in Request' for this planning application to be considered at planning committee.

NOTE: following the meeting and information provided from a member of the public that there was an ecological report included in the planning application that was carried out December 2018, para 6 has been deleted.

The Chairman expressed concern that the hedge had still not been cut back along the footpath between Coppice Drive and Cleveland Avenue. The Parish Clerk was instructed to follow this up.

Following concerns over a property in Cliff Crescent and the mess around this property which is causing concerns to residents in the area, Telford & Wrekin Council's Enforcement Officer was asked whether in their opinion any enforcement action can be taken. They had visited the site and confirmed that no formal legal action could be taken under Section 215 of the Town and Country Planning Act 1990 and there were no breaches of planning legislation.

Cllr Chris Purves reported on Michael Barkers recent correspondence as follows; The value of the initial draft is that it includes a broad range of contributions and comments that were received during consultation and the Parish Survey. But it consists of aspirations and concerns rather than up to date evidence and reasoned justification for the policies that are included. There are significant gaps in the document and evidence that needs to be updated in order for the NDP to be in general conformity with the National and Local Development Plan policy as required by under the Regulations for the preparation of Neighbourhood Plans.

However the Evidence Review, Early Engagement and Consultation report prepared by the Parish Council will address these matters. The next stage will be to produce a new and revised Draft NDP that complies with the Basic Conditions for Neighbourhood Plans, National planning policy, local strategic Development Plan policies, and the Government regulations for Neighbourhood Plans and makes a positive contribution to sustainable development.
