# 0150/12/23.C Chairman's Report and Correspondence

## a) The Cleveland Arms

A communication from the owner had been circulated to all Members, as requested, for information.

Councillor Connor updated Members on matters since the November meetings. It had been necessary to hold some discussions in private sessions due to the commercially sensitive nature of the agenda items. Discussions had taken place to establish an agreed approach by the Parish Council towards the subject of the Cleveland Arms, following the Inspector's support for the refusal of the planning application for change-of-use.

The Parish Council had been made aware of two, and possibly three, potential companies interested in the Cleveland Arms, each requiring a current valuation. The Parish Council had agreed, through a tender process, to engage the services of Andrew Dixon & Company (Commercial Property Consultants, Estate

Agents and Chartered Surveyors). The current valuation, when available, can be shared with all prospective purchasers so that they are in a position to make an informed decision and contact the owner for further communication. There need be no involvement by the Parish Council in these discussions.

# 0151/12/23.C Finance & Governance

#### a) Finance & Governance Meeting

iii) It was proposed by Councillor Hughes, seconded by Councillor Hartshorn, all were in favour and thus it was

RESOLVED that the application for the CCLA Investment Account be completed as soon as possible and that £25,000 be transferred from Reserves at the earliest opportunity.

#### c) Financial Reports

A copy of the current Bank Reconciliation had been circulated for information. There is currently a balance of £102,745.00 in the current account.

#### c) Other Planning Matters

#### i) TW Local Plan Consultation

The consultation period has been extended to 31st January 2024.

Members are reminded to take a look at the proposals and to keep in mind the policies within the Ercall Magna Neighbourhood Plan. This will appear on the January agenda for consideration. Members are encouraged to submit their own views, too. A letter from Mark Pritchard MP, on this subject had been circulated to all members and encouraged the Parish Council to engage in the consultation process.

#### ii) Enforcement Issues

Members continue to question the delays regarding outstanding enforcement matters. This will be raised with the Planning Authority and an urgent request for updates be submitted.

#### iii) Emergency Planning

The fourth session will take place on 26<sup>th</sup> January from 10am until 3pm at The Shirehall. Councillors Hughes, Wickson and Purves will attend.

# iv) High Ercall Conservation Area Management Plan

Unfortunately, there is likely to be a delay in the updating of the CAMP due to changes in personnel at TWC. However, Councillor Hughes will meet with Andy Gittens in January to consider the current Management Plan with a view to enhancing it to include the recent Green Space designations within the Neighbourhood Plan.

#### v) Ercall Magna Neighbourhood Plan

It was good to see that the EMNP policies have been cited within recent planning decisions. Members noted the EMNP policies and confirmed that they are relevant to the current planning considerations within the Parish.

## 0153/12/23.C Environmental Matters

#### a) Updates and New Issues

The Clerk continues to press TWC for action on numerous outstanding 'requests for action'

# 0154/12/23.C Highways & Transport Matters

## a) Reports and Updates

- i) The Roden Parish Councillors and residents are total frustrated at being let down by TWC for the lack of progress on the road improvement scheme to be provided and funded by Section 106 funds from local planning permissions.
  - It was agreed that a meeting should be demanded in order that they can meet with the Ward Member and Officers to ascertain why there are further delays.
- ii) It was also agreed that the Clerk should ask why the work at Cotwall Bend has not yet been completed.

#### b) SIDs

The new socket has been installed in Shrewsbury Road. TWC has confirmed that it is now waiting for the post, solar panel and SID to be installed at the site.

The Clerk continues to ask for an update on the installation of the remaining SID sockets around the Parish, including Cotwall Bend and Cold Hatton.

#### c) Rural Lanes

Whilst it is accepted that there has been excessive rain and therefore, additional flooding has occurred in recent months, the problems in Heath Lane, Crab Tree Lane and Poynton Road have been made worse by the lack of maintenance of the ditches and the effects of agricultural vehicles leaving the sites. There is a general poor state of lanes, particularly in the rural parts of the Borough.

#### d) Bus Shelters and timetables

Work to improve the Interchange Site at High Ercall has been requested and the provision of new bus timetables for all stops and shelters is necessary.

## e) Potholes

There are many areas, around the Parish, where deep potholes exist but cannot be seen (particularly by cyclists) and when full of water. It was disappointing to be informed that TWC have said 'they will not come out to inspect certain potholes'. With a reference number, this will be raised through Customer Relations. Issues remain in Shrewsbury Road, Rowton and along the Walton to Shawbury Road.

#### f) A442 Cold Hatton

Cllr Taylor reported that a number of the central refuge islands at Cold Hatton have now been knocked out of position and this leaves the area more dangerous, as the bases are still in situ and cannot be seen. Whilst it is accepted that the road needs to be safe for crossing, members did question the success of this scheme. As a minimum, the remaining bollards needs to be cleaned.

# 0155/12/23.C Play Areas

#### **Roden & High Ercall**

The RoSPA reports have identified some low-risk matters, some of which are being dealt with, but others will need parts to be ordered.

Woodchip will be required for all sites next Spring.

#### 0156/12/23.C Shropshire Association of Local Councils

- a) Regular updates are provided to all members and contain useful information.
- b) Councillor Wickson gave a short resume of current matters, including Martyn's Law, emergency planning and confirmed that the WAC Climate Change Motion will be accepted by SALC and forwarded to NALC. In the meantime, it is important that we all 'do our bit' towards Carbon Neutrality.

#### 0157/12/23.C Street Lighting

Councillor Wickson offered to meet the contractor on site when they arrive to cut back overgrown hedges and trees which block the streetlights. This remains a major issue.

# a) Councillor Bentley – Ercall Magna Ward

TWC is continuing to consider budget implications at this difficult time. Whilst this is accepted, there is a strong feeling that the current administration does not have its priorities correct. There have been a number of meetings regarding issues in the Ward recently and it is sincerely hoped that some will bring forward more action especially on old issues relating to planning, development, highways and much more.

A bus shelter will be provided outside of Cliff Crescent, Ellerdine and the bus stop will move from the Village Hall location. It is also anticipated that the old bus shelter on the corner of the Hilbrae Road and the A442 at Cold Hatton will be removed in the New Year.
