## 123/10/24.C Planning

#### a) Report

The Chairman of the Planning Committee, Councillor Wickson, updated members on applications recently determined by TWC – details have been sent to all members. TWC/2024/0637 The Lilacs – permission granted for (lower) gates as requested by the Parish Council

#### b) New Planning Applications for consideration

i) TWC/2024/0687 Rainbow Farm, Rowton Erection of a General-Purpose Agricultural Storage Building

There was some confusion regarding the consultation regarding this application. However, the Parish Council had not previously responded and the Chairman and Vice Chairman, under delegated powers

RESOLVED that the Parish Council would respond to confirm support for the application.

### c) Other Planning Matters

#### **Emergency & Resilience Planning**

Councillor Hughes updated Members on the meeting of the Working Group and confirmed that this will appear on the Finance & Governance Agenda for further consideration of the Draft Plan. A letter has been drafted to be sent to all residents with a request for assistance sent to the businesses previously identified.

Members also discussed including this as the main article in the next Parish Council newsletter.

#### **Appeal Hearings**

#### Land Rear of Stackstones (known as Piddock's Paddock)

The Chairman had been in contact with the Planning Officers to discuss the procedure for the hearing, scheduled for 16<sup>th</sup> October 2024 at AFC Telford.

TWC had refused permission for up to 5 self-build properties and the applicant has appealed the decision. Although the correct version of the Ercall Magna Neighbourhood Plan had been provided throughout the process at Regulation 15 and included in the Public Referendum, the incorrect Plan had been added to the TW website.

This has been updated and the Inspector has been informed.

## 124/10/24.C Environmental Matters

## a) Updates and New Issues

The Clerk continues to press TWC for action on numerous outstanding 'requests for action'. TWC has confirmed that the grass cutting schedules have commenced, but are at least two weeks behind. Leaves will be the biggest issue in the coming weeks – please report any 'dangerous' locations on My Telford. Overgrown hedges are causing visibility problems around the parish.

The path from the Shop to Park Lane needs attention – whilst asking TWC if it is their responsibility, they sent a GIS map so that this information can be available to us. Where it is not TW responsibility, the Parish Council can arrange for this work to be undertaken.

It was agreed to get a quotation from Nobridge Nurseries for footpath (and possible) road sweeping.

It was also noted that the hedges to the rear of 54 - 58 Talbot Fields need attention to enable the footpath to be used. This will be reported to the Rights of Way Team at TW.

#### b) Tree Branches

It was noted that some street lights are ineffective due to overgrown trees and hedges – landowners are requested to take a look to ensure that any lights near their property are not hidden by trees or hedges that are their responsibility.

## 125/10/24.C Highways & Transport Matters

## a) Reports and Updates

## Silver Hill, High Ercall

The potholes have been filled.

The quotation for the solar SID and post is still awaited. This will be needed before the next meeting with Greenhous Village Management.

#### b) Ercall Magna Traffic Schemes

As requested, a full list of local issues had been produced and sent to TWC. Their acknowledgement confirms receipt but also states that some are being dealt with by different departments. The document will be useful for reference and will be kept up to date as actions happen.

The list will be used on the website to update the community on action taken by the Parish Council on their behalf.

## 127/10/24.C Telford & Wrekin Council

#### a) Ercall Magna Ward

Councillor Bentley reported that work is continuing with regards to the budget for 2025/26 – there are likely to be difficult decisions. The review of the Local Plan is likely to be delayed due to possible changes within the NPPF which the Government are considering.

Enforcement issues in the Ward have been hindered – an application to the High Court will mean further delays.

#### b) Wrockwardine Ward

Councillor Thomas had hoped to deliver an update on the Community Governance review, however, the recent meeting was postponed again. It has 'all gone quiet' regarding the Local Plan Review and other significant matters, too.

## Roden & High Ercall

Minor repairs are necessary at High Ercall.

Confirmation had been received that both play areas are insured by the Parish Council within the current policies.

A comment was received as to how nice it is to hear the children's football teams when using the Playing Field.

The Parish Council has received 96 (free) bulbs to be used to encourage residents to upgrade to LED in order to assist with reducing electricity bills at this difficult time.

#### a) Ellerdine Village Hall

Councillor Connor declared an interest, and had a dispensation in place

Councillor Connor gave an update on the unauthorized use of the car park (especially by buses). Members of Ellerdine Village Hall Committee are in regular contact with TWC regarding the issues caused.

#### b) High Ercall Village Hall

Councillors Wickson, Noyes-Thomas and Grant declared an interest but have dispensations in place
Councillor Noyes-Thomas had provided a report which included details relating to increased bookings, toilet
refurbishments is out to tender, position of treasurer remains vacant, work continues on the title
registration.

Councillor Grant confirmed that an agreement is in place with Ercall Colts Football Team, which have agreed to fund all football-related costs.
