## 068/06/24.C Planning

#### a) Report

The Chairman, Councillor Wickson, confirmed that applications for the Old Rectory and 5 Moortown had been granted permission.

## b) New Planning Applications for consideration

Councillors S Walker and S Bentley left the meeting

i) TWC/2024/0322 Land adjacent to Lindum House, Roden Change of Use to One dwelling

This application had previously been discussed, at length, and the Parish Council confirmed that it had no objection to the principle of change of use. However, concerns remain regarding the safety aspects of having the access directly onto the Lane, which is privately owned. It was

RESOLVED that the Parish Council position remains unchanged and the response would request that the Planning Officer considers the access rights on the adjacent lane and the effects of parking.

ii) TWC/2024/0378 Ercall Park, Walton
Barn Conversion

RESOLVED that the Parish Council would support this application. It is in accordance with the Ercall Magna Neighbourhood Plan.

## c) Other Planning Matters Llanhaven Close, Roden

It was pleasing to be informed that the TW Licensing Committee had agreed with the Parish Recommendation for the name of the road for the new properties. The history of the site had been taken into consideration. This decision has been challenged by the Developer and a full response has been received today from TWC to confirm that there is no appeal process.

## 069/06/24.C Environmental Matters

## a) Updates and New Issues

The Clerk continues to press TWC for action on numerous outstanding 'requests for action'.

#### b) New Matters

i) Overgrown hedges are a concern around the Parish, these can be reported at any time, to the Clerk – there is no requirement to wait to bring these to a meeting. The following landowners will be approached:

Pidduck's Paddock

If action is not forth-coming to improve access and visibility, these will be reported to TWC

ii) Right of Way – Church Car Park to Shirlowe This involved a number of landowners, including the Primary School – the Rights of Way department has been asked for assistance to clear the route to enable access.

## iii) Crows

A concern was raised about the increase in numbers (and therefore the increase in noise). Whilst it is accepted that this is seasonal, further information will be investigated.

## 070/06/24.C Highways & Transport Matters

#### a) Reports and Updates

The Clerk continues to press TWC for action on numerous outstanding 'requests for action'.

#### **Roden Traffic Calming Scheme**

Councillor Thomas confirmed that had not received any further updates on the outstanding matters In Roden. He would send a reminder to TWC. However, Members were unhappy that this scheme has not been completed. This is not a funding issue as the funds were provided by the landowner on a Section 106 Agreement.

It was agreed that further action is necessary and, following the election, a press release will be issued to raise awareness of the unacceptable delay in getting essential work done in the rural areas.

No action has been taken regarding the road surface outside of Nursery Gardens, which has sunk following

utility works.

The Clerk had responded to Chris Pearson with details of the Parish Council's wish to provide village namesigns following his suggestion for new signs on the B5062 and B5063. Details of the number of signs needed for each village had been provided with a request for information confirming which villages TWC is to provide for, so that the Parish Council can consider providing signs for the other villages. It is important that the design and colours are consistent throughout the Parish and include the Parish logo. This may mean a delay in providing for Roden and Poynton, until a decision of the Boundary Committee is confirmed.

#### **Cliff Crescent, Ellerdine**

An urgent works request has been submitted to alleviate the deep potholes that have been created near to the bend within Cliff Crescent estate. It was also noted that the road surface has broken up (opposite number 15). Kerb stones are missing and the area would benefit from road sweeping. More information will be added to the current works request. Consideration should be given to applying for HS2 funding to rectify the number of issues in this area of the Parish.

#### Silver Hill

The road closure was extended to deal with the STW leak. This has affected the drains at the bottom of Silver Hill and on the B5062.

#### b) Other Matters
