<p><b><u>Contracts</u></b></p> <p>Any contract which is made between you or your partner (or a body in which you or your partner has a beneficial interest<sup>4</sup>) and the Council —</p> <p>(a) under which goods or services are to be provided or works are to be executed; and</p> <p>(b) which has not been fully discharged.</p>	<p>N/A</p>

<sup>5</sup> "land" excludes an easement, servitude, interest or right in or over land which does not carry with it a right for the relevant person (alone or jointly with another) to occupy the land or to receive income:

**Corporate tenancies**

Any tenancy where (to your knowledge)—  
(a) the landlord is the Council ; and  
(b) the tenant is a body in which you or your partner has a beneficial interest.

Any beneficial interest in securities<sup>6</sup> of a body where—  
(a) that body (to your knowledge) has a place of business or land in the area of the Council ; and  
(b) either—

(ii) if the share capital of that body is of more than one class, the total nominal value of the shares of any one class in which you or your partner has a beneficial interest exceeds one hundredth of the total issued share capital of that class.
